Said he's getting calls that people can't drive down the road, kids are taking their sweet time getting out of the road. Said he talked to the Chief of Police and

they are going to work on it and if they don't get any results, they will go further than what they will do now.

Supervisor Richardson said the other day they met with Microenterprise and people in town will be notified shortly of their award which is all part of the \$168,000 grant money.

Comm. Seber said even the administration is included.

Supervisor Richardson said there is no cost to the city.

Mayor Sylvester opened up the meeting to public comment.

Norine Cunningham, 1 Tenendaho Lane, said they are having a little cleanup day. Said the Express put an ad in the paper for her.
