NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Mechanicville finds that:

- Charter Communications has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. The quality of the Charter Communications service, including signal quality response to customer complaints and billing practices has been in light of community needs; and
- Charter Communications has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 4. Charter Communications can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the City Council of the City of Mechanicville herby renews the cable television franchise in the City of Mechanicville for fifteen (15) years commencing on the date of approval by the Public Service Commission.

BE IT FURTHER RESOLVED that the City Council of the City of Mechanicville hereby confirms that this Franchise Renewal Agreement replaces the original franchise last amended on November 21, 2003.
